- Transfer to and attend a BGDI in the academic year for which you are initially a Cal Grant (Ex. Any term in the very next year); and
- Have a verified GPA of 2.40 and on a 4.0 scale based on a minimum of 24 semester units of the equivalent; and
- Students who are under the age of 28 by December of the award year

A 2003 CA State Tax Return if graduated CA H.S. in 2004**) **OR** if your parent(s)/legal guardian(s) did not file a CA State Tax Return for the year requested, they **MUST** provide one of the following documents for the calendar year immediately prior to your high school graduation or its equivalent:
    - California lease or rental agreement
    - California auto registration
    - California bank account records
    - California utility bill
  - **OR (If applicable):** Attach a copy of Parent(s) military records verifying relocation order from CA dated prior to your high school graduation or its equivalent **AND** at least one of the documents listed above for a period that pre-dates relation orders
